
## Reinforcing the internal market through further digitalization

It is a great challenge for European shipping to remain competitive globally. In addition to investing in newer and more environmentally friendly ships and building maritime infrastructure, the digitalization of business processes is also an important factor for more profitable transport operations that result in more competitive internal and external trade. In addition to topics extremely relevant to digital development, such as EMSW, the introduction of e-bill of lading (eFTI), the establishment of an ESW for the customs system and digital inland navigation tools, in order to further develop a successful single internal market, it is important to ensure the integration of existing MS systems into a single large data exchange system reducing administrative burden and securing seamless transport of freight and passengers from door to door. In order to exercise in full the re-use of data, it is also important that this system integrates individual systems of different branches of the economy.

#### Investing in future of seafaring profession

From safety, environmental perspective as well as to maintain the competitiveness of our maritime workforce, a high level of competence of the European seafarers is necessary. 
## 12:15 – 12:45 III KEY NOTE

Cape Town Agreement of 2012 on the Implementation of the Provisions of the Torremolinos Protocol of 1993 relating to the Torremolinos International Convention for the Safety of Fishing Vessels, 1977

The Cape Town Agreement treaty will enter into force 12 months after at least 22 States, with an aggregate 3,600 fishing vessels of 24 m in length and over have expressed their consent to be bound by it.

During the Ministerial conference held in Torremolinos, Spain 21-23 October 2019, representatives of 48 States have signed the Torremolinos Declaration, publicly indicating their determination to ensure that the 2012 Cape Town Agreement on fishing vessel safety will enter into force by the tenth anniversary of its adoption (11 October 2022). The Torremolinos Declaration remains open for further signatures until 21 October 2020.

Member states of the European Union should also have in mind the Council Decision of 17 February 2014 authorizing Member States to sign, ratify or accede to the Cape Town Agreement of 2012 on the Implementation of the Provisions of the Torremolinos Protocol of





1993 relating to the Torremolinos International Convention for the Safety of Fishing Vessels, 1977 (Text with EEA relevance).

<u>Greening of the shipping sector – 2030 Vision - Facilitating sustainable shipping solutions for</u> <u>GHG emission reduction</u>
