This Circular summarizes the requirements of the Annex of the Protocol of 1997 to the International Convention for the Prevention of Pollution from Ships (MARPOL Annex VI), the International Convention for the Control and Management of Ship's Ballast Water and Sediments (BWM), the Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships and the International Maritime Solid Bulk Cargoes (IMSBC) Code, entered into force from January 2025 as listed in the Annex to this Circular.

List of MARPOL, BWM, Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships and the International Maritime Solid Bulk Cargoes (IMSBC) Code, entered into force from January 2025.

Below table provides reference to adopted MSC, HKSRC and MEPC Resolutions, dates of their entry into force with short description of the nature and scope of requirements.
