MULTILATERALNI POSEBNI SPORAZUM RID 1/2020
sukladno odjeljku 1.5.1 Propisa RID
o uvjerenjima o profesionalnoj obuci
savjetnika za opasne tvari sukladno odredbi 1.8.3.7 Propisa RID

- (1) Odstupajući od odredaba 1.8.3.16.1 Propisa RID, sva uvjerenja o profesionalnoj obuci sigurnosnih savjetnika za opasne tvari koja imaju rok valjanosti između 1. ožujka i 1. studenoga 2020. godine vrijede do 30. studenoga 2020. godine. Navedena uvjerenja obnavljaju se na pet godina od izvornog datuma isteka uvjerenja ako vlasnici tih uvjerenja polože ispit u skladu s odredbama 1.8.3.16.2 Propisa RID do 1. prosinca 2020. godine.
- (2) Ovaj Sporazum vrijedi do 1. prosinca 2020. godine za prijevoz na državnim područjima ugovornih stranaka Propisa RID koje su potpisnice ovog Sporazuma. Ako ga neka od potpisnica otkáže prije tog datuma, on ostaje na snazi do gore spomenutog datuma samo za prijevoz na državnim područjima onih ugovornih strana Propisa RID koje su potpisnice ovog Sporazuma, a koje ga nisu otkazale.

MULTILATERAL SPECIAL AGREEMENT RID 1/2020
under section 1.5.1 of RID
concerning safety adviser certificates
in accordance with 1.8.3.7 of RID

- (1) By derogation from the provisions of 1.8.3.16.1 of RID all certificates of training as safety adviser for the transport of dangerous goods the validity of which ends between 1 March 2020 and 1 November 2020 remain valid until 30 November 2020. The validity of these certificates shall be extended from the date of their original date of expiry for five years, if their holders have passed an examination in accordance with 1.8.3.16.2 of RID before 1 December 2020.
- (2) This agreement shall be valid until 1 December 2020 for carriage on the territories of the RID Contracting States signatory to this Agreement. If it is revoked before that date by one of the signatories, it shall remain valid until the above-mentioned date only for carriage on the territories of those RID Contracting States signatory to this Agreement which have not revoked it.
