The introduction of e-vignette and toll in Bulgaria as a modern way of charging the use of the national road network will begin from 2019.

In order to use the road network, you have to purchase an e-vignette for your vehicle. The e-vignette for vehicles of more than 3.5 tons will be valid until and including 15.08.2019.


As of 16 August, vehicles of more than 3.5 tons will be subject to a toll – a charge depending on the distance travelled.

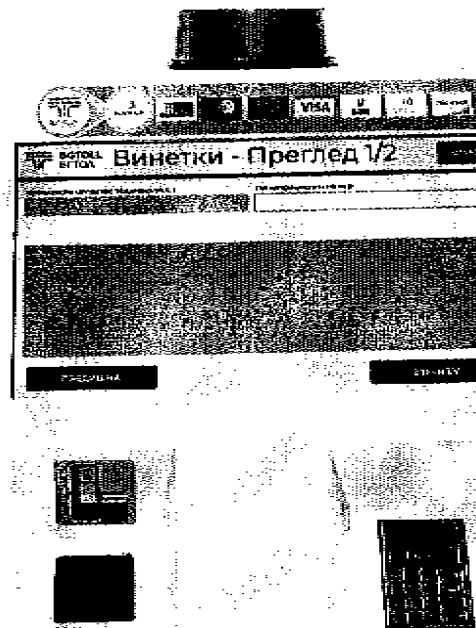

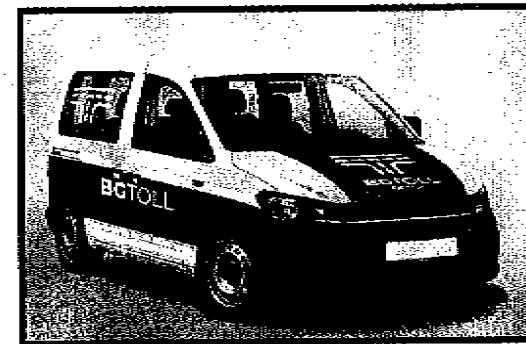
 At 500 self-service terminals in points of sale throughout the country

 At cash desks in the points of sale and at Road Infrastructure Agency's regional offices.

 The purchase of e-vignettes can be done via debit, credit and fuel cards as well as via wire transfer or in cash at a cash desk.



### WHO WILL CARRY OUT CONTROL AND WHAT HAPPENS IF YOU VIOLATE THE RULES?



Control will be carried out by road network cameras as well as by 105 toll control mobile units.

Your vehicle's number plate will be automatically checked in the system, showing whether the relevant road charge has been paid.

In case of violation, the enforcement bodies will give you the opportunity to pay a compensatory charge, which is less than the fine. That charge can be paid via card at the toll control unit or via wire transfer within a period of 14 days. If you do not pay within this period, a fine will be imposed against you.

### HOW WILL THE PAPER VIGNETTE CONVERT TO AN ELECTRONIC ONE?

Paper vignette stickers purchased in 2018 and valid after 1 January 2019 will remain valid.

Drivers will have to leave the paper sticker to their car's windshield until the date it becomes invalid.
