Multilateral Agreement M324

under section 1.5.1 of ADR
concerning driver training certificates in accordance with 8.2.2.8.2 of ADR
and safety adviser certificates in accordance with 1.8.3.7 of ADR

1. By derogation from the provisions of the first paragraph of 8.2.2.8.2 of ADR all driver training certificates the validity of which ends between 1 March 2020 and 1 November 2020 remain valid until 30 November 2020. These certificates shall be renewed for five years if the driver furnishes proof of participation in refresher training in accordance with 8.2.2.5 of ADR and has passed an examination in accordance with 8.2.2.7 of ADR before 1 December 2020. The new period of validity shall begin with the original date of expiry of the document to be renewed.
2. By derogation from the provisions of 1.8.3.16.1 of ADR all certificates of training as safety adviser for the transport of dangerous goods the validity of which ends between 1 March 2020 and 1 November 2020 remain valid until 30 November 2020. The validity of these certificates shall be extended from the date of their original date of expiry for five years if their holders have passed an examination in accordance with 1.8.3.16.2 of ADR before 1 December 2020.
3. This agreement shall be valid until 1 December 2020 for carriage on the territories of the ADR Contracting Parties signatory to this Agreement. If it is revoked before that date by one of the signatories, it shall remain valid until the above-mentioned date only for carriage on the territories of those ADR Contracting Parties signatory to this Agreement which have not revoked it.

Multilateralni sporazum M324

sukladno odjeljku 1.5.1. ADR-a
o uvjerenjima o osposobljenosti vozača u skladu s 8.2.2.8.2. ADR-a i
Savjetnika za sigurnost sukladno 1.8.3.7 ADR-a

1. Odstupajući od odredaba prvog stavka 8.2.2.8.2 ADR-a sve ADR potvrde o obuci vozača koje ističu između 1. ožujka 2020. i 1. studenoga 2020. vrijede do 30. studenoga 2020. Te ADR potvrde obnavljaju se na pet godina ako vozač dostavi dokaz o sudjelovanju na obnovi znanja u skladu sa 8.2.2.5. ADR-a te položi ispit u skladu s 8.2.2.7. ADR-a do 1. prosinca 2020. Novi rok važenja počinje teći od izvornog datuma isteka dokumenta koji se obnavlja.
2. Odstupajući od odredaba 1.8.3.16.1 ADR-a, sva uvjerenja o osposobljenosti sigurnosnih savjetnika za prijevoz opasnih tvari koja ističu između 1. ožujka 2020. i 1. studenoga 2020. vrijede do 30. studenog 2020. Ta uvjerenja obnavljaju se na pet godina od izvornog datuma isteka tih uvjerenja ako njihovi imatelji polože ispit u skladu s 1.8.3.16.2 ADR-a do 1. prosinca 2020.
3. Ovaj sporazum vrijedi do 1. prosinca 2020. za prijevoz na državnim područjima ugovornih stranaka ADR-a koje su potpisnice ovog Sporazuma. Ako ga neka od potpisnica otkáže prije tog datuma, on ostaje na snazi do gore spomenutog datuma samo za prijevoz na državnim područjima onih ugovornih strana ADR-a koje su potpisnice ovog Sporazuma, a koje ga nisu otkazale.
